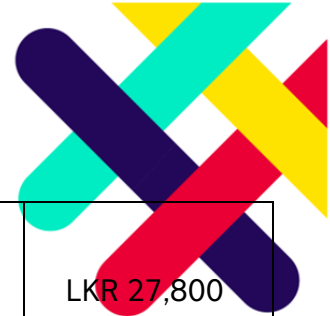
## 1. Enquiry about Examination Results (EAR) / Re-correction

**EAR IAL Deadline – 7th February 2025**

**EAR IGCSE Deadline – 14th February 2025**

**Late requests will not be accommodated.**

**Refunds for EAR are given only under the following circumstances:**

**IAL:**

- Cashed-in Subject (i.e., awarded an overall subject grade) – If the EAR leads to an improvement in the overall subject grade.
- Non cash-in Subject – If the EAR leads to an improvement in the unit grade.
- Cashed-in Subject with multiple units requested for EAR- Only the EAR unit contributing towards an improvement in the overall subject grade will be refunded.

**IGCSE / GCSE / GCE AL:**

- Refund of fees (per relevant subject) will be applicable only if the EAR service leads to an improvement in the overall subject grade.

**Note:** Candidates' marks and subject grades may be confirmed, lowered or increased. Where there has been a reduction in marks or a downgrade, the request cannot be revoked, and the original mark or grade cannot be reinstated.

## 2. Access to Scripts (ATS)

**IAL Deadline – 31<sup>st</sup> January 2025**

**IGCSE Deadline – 7<sup>th</sup> February 2025**

**Late requests will not be accommodated**

Access to Scripts (Copy of scripts to support EAR)	Access to Script service allow you to request copies of your marked exam papers. Scripts do not have examiner annotation on them, but you can see the marks.  Copy of scripts are available for candidates to decide whether to go ahead with an EAR Service request.  <i>School Candidates: Need to Apply through their respective school.</i>	LKR 2,500

### 3. Late Cash-In for Oct/Nov 2024 series

Candidates, who have completed the required number of units, may apply for this service.

**Deadline – 24<sup>th</sup> January 2025 (Late requests will not be accommodated)**

#### Fees

- Per Cash In – LKR 7,500

**Note:** Late Cash-ins for Oct/Nov 2024 series are only allowed up to the above deadline. Any cash in requests made after the above date will need to be submitted as a Special Late cash-In request.

#### Requirements:

- Late Cash-In application form.
- Statements of Results (*Current and all relevant previous results sheets*)
- Copy of your ID (*Name should appear in English*)

### 4. Data Changes

If there are any mistakes in the spelling of your name, date of birth and gender, apply for “Data Changes” before the given deadline using the form linked below.

**Deadline – 27<sup>th</sup> January 2025.**

**Note:** Any requests submitted after the above deadline will be subject to board approval and fee of LKR 30,600.

### 5. Certificate

You will receive your SOR by early February 2025 and the Certificate by mid-April 2025.

- **Private Candidates** - Sent via courier to the registered address.
- **School Candidates** - Sent to the respective schools.

If you are a private candidate residing outside of Sri Lanka and would like your Statement of Results (SOR) and Certificate to be couriered to your address. You are required to make an overseas courier payment of **LKR 14,000/-**

You can either opt for us to courier each document (SOR and Certificate separately) or together once the certificate arrives.

If requesting the documents to be couriered separately you will need to pay **LKR 28,000/-**

**Note:** Please be advised that unclaimed certificates will no longer be available after a period of one year. In such cases, candidates will be required to request a certifying statement of results instead.
